Assignment Title: Supervision of the Resettlement Area of Impact (RAI) Structures Demolition Consultancy

The Government of Sint Maarten has received financing from the World Bank toward the cost of the Emergency Debris Management Project and intends to apply part of the proceeds for consulting services.

The consulting services (“the Services”) include the provision of contract administration and site supervision services for the demolition of structures in the Resettlement Area of Impact. This includes overseeing waste processing and clearance activities and ensuring adherence to the specifications outlined in the contract documents for the Works.

The expected implementation period is 9 months, and the assignment is expected to start on July 2024.

The National Recovery Program Bureau (NRPB) now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The selection criteria are:

1. The consulting firm must be duly registered or incorporated, either on a national or international level.
2. Experience in management and supervision of civil works or related works with at least 10 years of experience.



3. Demonstrated financial stability and capacity to manage supervision projects for one year of implementation.
4. Evidence of successfully completed supervision of projects within the last 5 years.
5. Experience in supervising the implementation of Contractors' Environmental & Social Management Plan.
6. Qualification and Experience of Key experts based on the TOR requirements.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" dated November 2020 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the Consultant's qualifications-based selection method set out in the Procurement Regulations.
