The consulting services ("the Services") include the hiring of an individual to review the interior functionality of each Public Service Center (PSCs) and recommend necessary improvements (interior designer), in order to design the plans for the improvement of the PSCs at Philipsburg and Simpson Bay in coordination with the relevant government officials, taking into account previous work done on the PSCs and specifically the following documents: (i) the PSC Improvement Plan; (ii) the focus group feedback and (iii) any existing contingency plans as well as all other relevant documents provided by the Government of Sint Maarten.

Applicants are free to choose a format for their Expression of Interest. At this stage, Consultants are expected to provide:

- 1. CVs including relevant information about qualifications and expertise, strategic competencies or achievements;
- 2. Relevant references from previous similar projects/clients.
