The Government of Sint Maarten has received financing from the World Bank toward the cost of the Digital Government Transformation Project (“DGTP”) and intends to apply part of the proceeds for consulting services.

The consulting services (“the Services”) include **the development of recommendations on the policy and legislation related to cybersecurity, Data Protection and Privacy, and Open Data in Sint Maarten.** The Consultant shall coordinate and work with the digital transformation initiatives executed under the DGTP.

The National Recovery Program Bureau (NRPB) now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

The shortlisting criterion is:

- Demonstrated experience in advising on and drafting legislation relating to the development of digital transformation in the public sector (similar experience with Dutch and/or Dutch Antillean governments and/or municipalities is an advantage) - 50 points;
- Demonstrated experience in key legal areas and international best practices in cybersecurity, data protection and privacy, and open data - 50 points.

Key Experts will not be evaluated at the shortlisting stage.



The attention of interested Consultants is drawn to Section III, paragraphs 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" November 2020 edition ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture, association or consortium that may or may not be a new legal entity between members who would be jointly and severally liable for the performance of the assignment. The Consultants should indicate whether the Expression of Interest is being submitted as a Joint Venture or otherwise. Please note that the experience and references of sub-consultants shall not be taken into account in the evaluation of Expressions of Interest.

A Consultant will be selected in accordance with the Quality and Cost-Based Selection (QCBS) procedure set out in the World Bank's Procurement Regulations referenced above.

Consultants must provide all information indicating that they are qualified to perform the Services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff etc.).
