1. The Government of Sint Maarten has received financing from the World Bank toward the cost of the Emergency Debris Management Project (EDMP) and intends to apply part of the proceeds toward payments under the contract for *Tire Removal Services*
2. The *National Recovery Program Bureau (NRPB)* now invites sealed Bids from eligible Bidders for the procurement of services for the waste tire removal from stockpiles located on the east side of the MSWDS.
3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" - November 2020 revision ("Procurement Regulations")<sup>1</sup> and is open to all eligible Bidders as defined in the Procurement Regulations.

5. This tender follows an electronic submission procedure further elaborated in Section II. Bid Data Sheet (BDS) of the RFB. Encrypted/password protected Bids must be sent to [tenders@nrpbxm.org](mailto:tenders@nrpbxm.org) on or before **10:00 AM (AST) on 12th February, 2025**.  
  
Encryption Key/and or password must be sent to [pool@bakertillycuracao.com](mailto:pool@bakertillycuracao.com) **on 12th February, 2025 between 10:01 AM (AST) and 11:00 AM (AST)**. Late Bids will be rejected. Bids will be opened by Video Conference in the presence of the Bidders' designated representatives on **12th February, 2025 at 11:00 AM (AST)**. Confirmation of receipt and video conferencing information will be shared upon receipt of timely Bids.
6. Documents that must be signed by an authorized representative should include language that digital copies of these documents will be treated as if they are originals. Original documents may be requested as part of the evaluation process and will be verified by the Employer before the signing of the contract.

7. All Bids must be accompanied by a *Bid-Securing Declaration*.
