The Government of Sint Maarten has received financing from the World Bank toward the cost of the Digital Government Transformation Project ("DGTP") and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") include the Development of ICT procurement policy and regulation for Sint Maarten. The Consultant shall coordinate and work with the digital transformation initiatives executed under the DGTP.

The National Recovery Program Bureau (NRPB) now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

The shortlisting criteria are:

- experience advising on and drafting legislation relating to the implementation of digital transformation projects and the development of ICT procurement policies;
- expertise in digital transformation management at national level, including the management, coordination and implementation of ICT related public procurements

Key Experts will not be evaluated at the shortlisting stage.

The attention of interested Consultants is drawn to Section III, paragraphs 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" November 2020 edition ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture, association or consortium that may or may not be a new legal entity between members who would be jointly and severally liable for the performance of the assignment. The Consultants should indicate



whether the Expression of Interest is being submitted as a Joint Venture or otherwise. Please note that the experience and references of sub-consultants <u>shall not</u> be taken into account in the evaluation of Expressions of Interest.

A Consultant will be selected in accordance with the Consultants Qualifications-based Selection method (CQS) set out in the World Bank's Procurement Regulations referenced above.

Consultants must provide all information indicating that they are qualified to perform the Services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff etc.).
